

ORDINANCE NO. 2235

AN ORDINANCE DESIGNATING THE EUREKA SPRINGS POLICE DEPARTMENT AS THE OFFICIAL RESPONSIBLE FOR THE COLLECTION OF FINES ASSESSED IN DISTRICT COURT FOR THE CITY OF EUREKA SPRINGS, ARKANSAS

WHEREAS, Arkansas Code 16-13-709 provides that the City must designate the official primarily responsible for the collection of fines assessed in District Court for the City of Eureka Springs, Arkansas; and

WHEREAS, the City Council finds it is appropriate to designate the Police Department of the City of Eureka Springs as the official responsible for the collection of fines assessed in District Court for the City of Eureka Springs, Arkansas.

NOW, THEREFORE, BE IT ORDAINED by the City Council of the City of Eureka Springs, as follows:

Section 1: The Police Department is hereby designated as primarily responsible for the collection of fines assessed in District Court for the City of Eureka Springs, Arkansas.

Section 2: All ordinances previously enacted in conflict with this Ordinance are hereby repealed.


